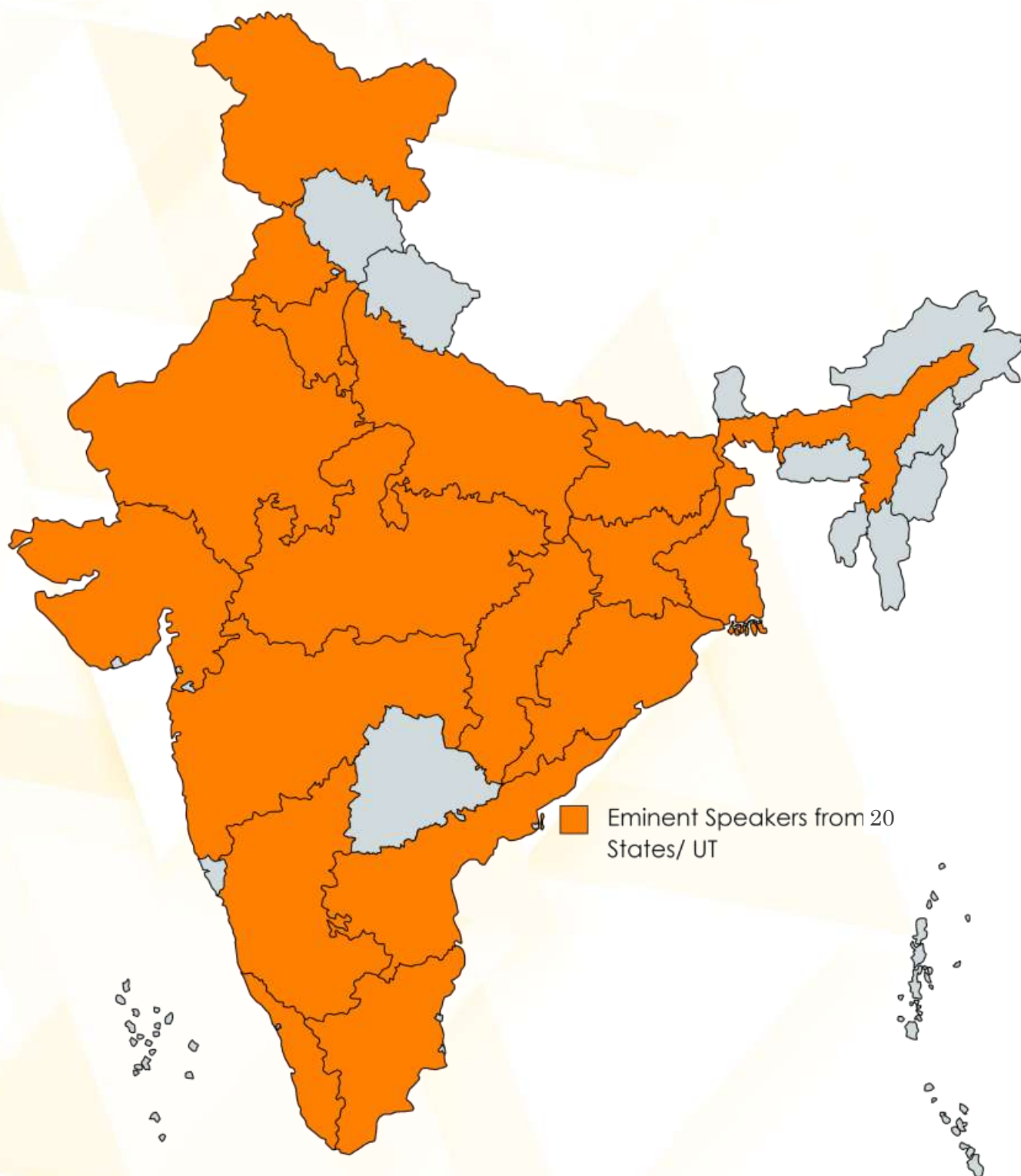

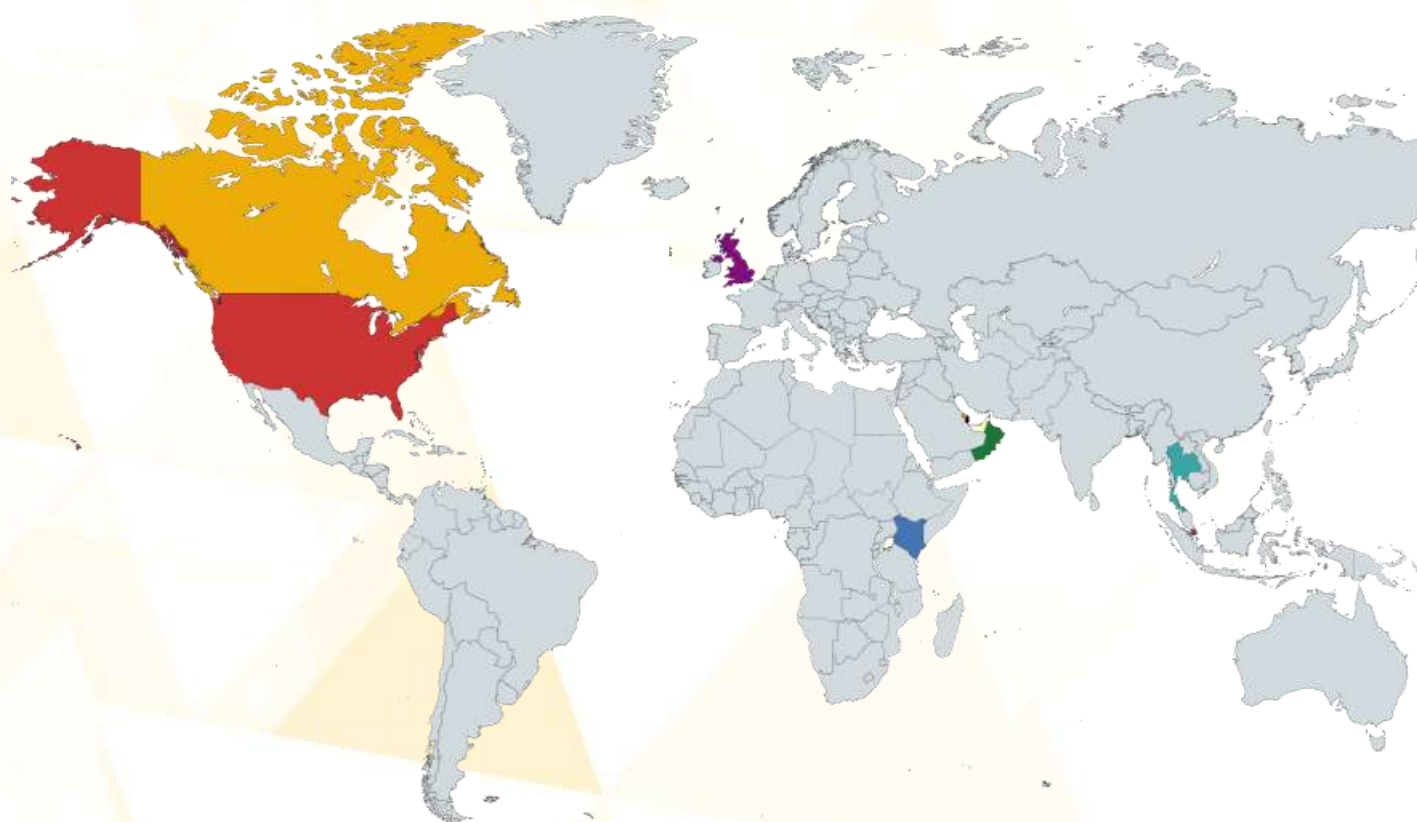

The Civil Services. When we think of the civil services, we instinctively think of the IAS or the IPS. However, for the Chartered Accountants, especially for those dealing in taxation, the interaction is the maximum with the officers of the Indian Revenue Service, be it in the Income Tax Department or in the Indirect Taxes. I was one such young CA who, right from his articleship, would visit the income tax offices and interact with a few IRS officers. The interactions motivated me to consider the civil services, and especially the IRS, as a career choice after clearing the CA exams. In this article, I make an attempt to share my story in brief and share a few advices for young CAs and CA students who aspire to join the civil services.

After clearing the CA Final exams and completing my articleship in the Corporate Tax Team in one of the Big Four firms, I did not sit for any campus placements and focused full time on preparing for the Civil Services Exams ("CSE"). I had planned that if I don't clear the exam in two attempts, I will get a job as a CA, so that I don't end up spending the crucial initial years of my career preparing for competitive exams and lose out on the updated professional knowledge expected from a CA.

By God's grace, I cleared the Civil Services Exams in my second attempt securing All India Rank 73 and joined the Indian Revenue Service (Income Tax). While a lot of people have been unable to comprehend my decision to join the IRS over any other service, I believe that being a CA, with the experience and interest in taxation, I have joined a department which gives me the most opportunities to learn and pursue my interest in taxation.

Why civil services? This is a question that most people either don't find an answer to or find all the wrong answers. Civil Services have proved to be an

enigma which many people aspire to join without fully appreciating the pros and cons that come with the job.

Firstly, it is just a job. Many young aspirants pursue the civil services thinking that clearing the exam would solve all the problems in their lives. Such a thinking is immature to say the least. One needs to aspire for it because it is a great job. The civil services give you opportunities like no other job can. It gives you the pleasure like no other job can. Having worked on both sides of the table in the Income Tax Department, I can share with my limited experience itself that the exposure and the learning opportunities are much greater while working as a tax officer than while working as a tax consultant. The variety of cases and the industries you deal with as a tax administrator gives you a much wider exposure than you can imagine. But at the end of the day, it is just a job. So even if you try & don't clear the exam, it is not the end of the world. You'll still gain from merely attempting for the civil service exam because the preparation itself teaches you a lot about this country & about yourself.

Secondly, one needs to be very clear about their motivations to appear for the CSE. If one wishes to appear for the exam only because their parents want them to, then probably that person won't go very far. If one wishes to appear for the exam because they are fascinated by the perks or the salutations, then again, they'll probably not go very far. A person may clear the exam with these motivations, but in the long term, I don't think they'll find the satisfaction in their life that one should aspire for. I believe that one should see the civil services as a means to be an end and not an end in itself. One should appear for the exams if one believes that the civil services will enable them to achieve something more in life like contributing to society, personal intellectual growth etc.

Thirdly, I believe that the CSE should not be considered to be an extremely tough exam that requires unthinkable hardwork. Yes, it involves a lot of luck

factor, especially at the prelims stage but it is an exam which can be cleared by CAs with adequate dedication. Every CA is aware that a minimum effort and preparation of at least 3-4 months is required to clear the CA Final exams. Any CA who clears both groups of CA final would have put in that minimum effort, if not more. For CSE, a person just needs to put in a similar effort with the only difference being that the effort has to be put in for a longer period of 9-10 months at least. Anyone who is willing to put in that level of minimum consistent hardwork can clear the CSE with a bit of luck on his / her side.

I believe that there is a great opportunity for CAs to enter into public service. As the Hon'ble Minister of Railways; Commerce & Industry, Sh. Piyush Goyal ji said in the recently held Residential Meet of Chartered Accountant Members in Public Service organized by ICAI, that the impact one can have on society through public service, on the destiny of more than a billion people, the work one can achieve as a Chartered Accountant through public service, can lead to large dimensional changes in the future of our nation.

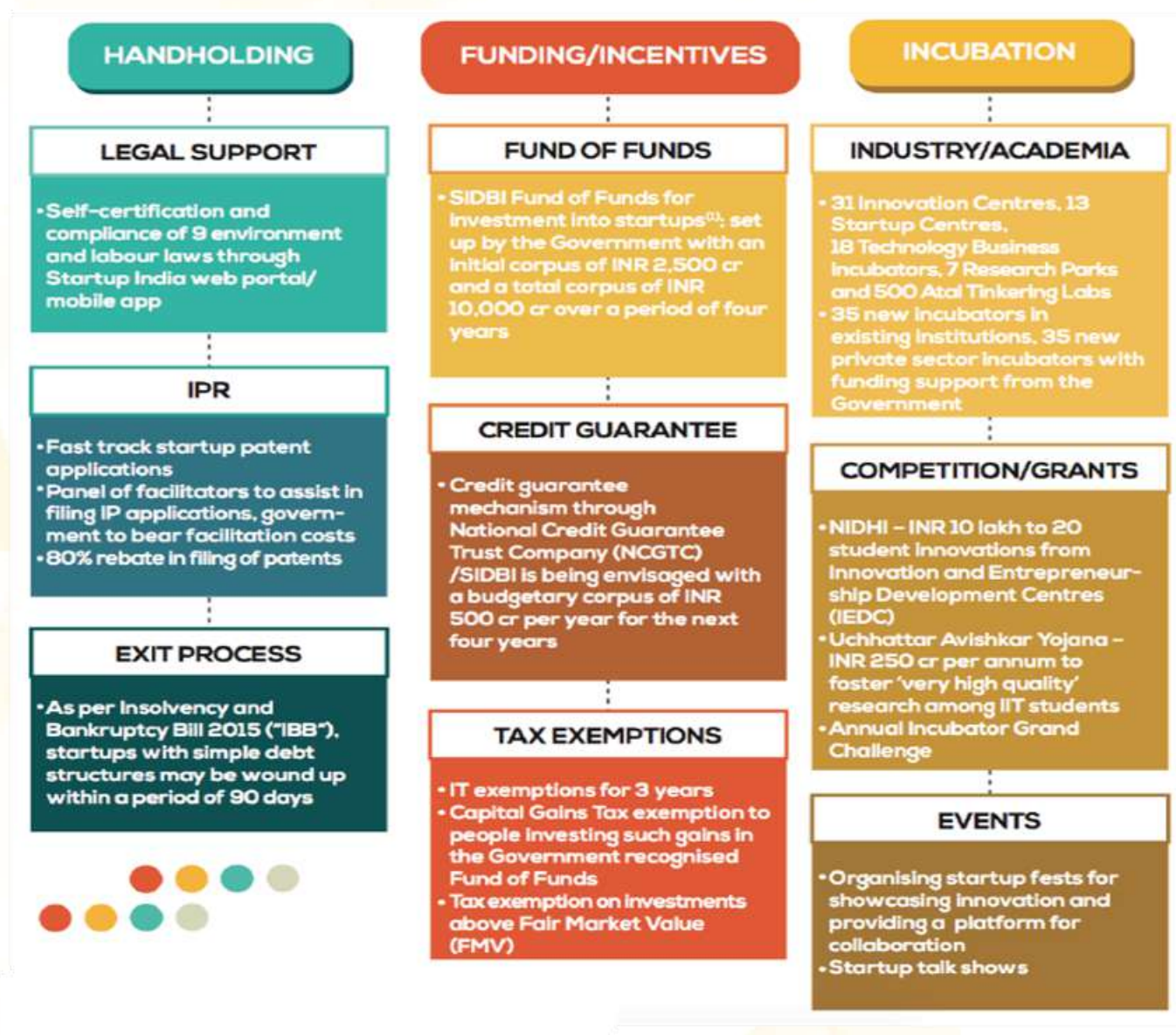

**Be Professional:** It is not advisable for a leader to be over committed or under committed. Use your all time and mark your commitments to the extent that will keep you productive always in your work while ensuring that you do not get unnecessary free time.

**Be Humane:** Last but not the least, never forget that you are human and you have to be humane. Always consider your team as your asset & not your sub-ordinates. No one likes being treated as inferior by a person unless. People work for a person only when they have a sense of belongingness with such person. Once a person gets connected with his team in such a subtle manner, his team will be his best supporters, advisors, critics but shall never betray him.

**Inspire others:** Leadership is all about knowing which direction to go and uniting the efforts of the team in such direction. However, to make a group of people travel in desired direction is a tough task. Everyone has got their priorities, interests and moreover ego; and that is where the challenge of a leader begins. *People become great by conduct, not by birth. Your Conduct should be elevated towards success.*

Success, by definition, means achievement of objectives. Thus, a successful person is an individual who accomplishes his objectives more often than he fails to do so. Success is largely defined by measures such as wealth, position or status. In addition, success is measured by one's capabilities. When we see someone around in our life succeed or hear about such a successful person who has established new dimensions of success, after seeing such a person. But very soon we are made to feel by the people around us that we cannot do it or it is not our cup of tea, then this is the end of our short term motivation and we start to believe that we cannot do all this. We get molded in the same fashion as the normal everyday life and the dreams of moving ourselves are finished before the beginning of the same.

### Goal

You must have a goal because, if you don't have a target, it is hard to tell when you will achieve it. Furthermore, if there is no goal, what would you focus on to assure a superior execution? However, just having a goal is not enough. Your goals must be smart. A smart goal is a goal that is achievable and which does not set you up for failure. An achievable goal is one that you are not sure you can achieve. This type of goal assures that you stretch your capabilities. An unachievable goal is one that you know you cannot achieve. Moreover, a smart goal is aligned with your ultimate goal. Otherwise, your accomplishments become trivial once you realize they have not made any contribution towards the ultimate goal, which consequently hurts your confidence and makes you depressed.

It is important that you stick with your goals and do not alter them after encountering the first obstacle. Yet, it is wise to be ready to change your goal once you realize a blunder or because of a change in environment. If the goal is changed repeatedly, you have to re-evaluate your ability of setting up smart goals. Furthermore if the ever changing goals have been set for others as well, you will soon lose respect and credibility.

**Focus**

In order to carry out your tasks efficiently you must be able to focus and concentrate on your task. Distraction will reduce your efficiency and will result in mistakes which may cause a total collapse of the mission. If possible, write your goal in large font and post it on the wall where you can be reminded of it frequently. Keep your eye on the target. If you are distracted, stop what you are doing and take care of the source of the distraction first. Very easy to say than to do, but, in many cases, it is often easier to do as well. The source of distraction might be as simple as tiredness, so take a break, rest, and get back to work with a rejuvenated energy.

**Hard Work**

We talked about doing something that one has talent for. Obviously, the less talent one has for the job they do, the harder one has to work to get the results they desire.

Successful people often enjoy their job so much that it does not seem like work, never mind hard work. On the negative side, when these people retire, they quickly deteriorate because they lack the stimulus of their work. While they were so fully and constantly occupied with their work and career, they never developed any type of hobby to fall back to in retirement.

The important thing is to understand the difference between passing time *Vis a vis* time management and to know that being busy is not the same as working. It's the key to work on the important, not necessarily the urgent.

The attitude of a successful person is the 'CAN DO' attitude. When a problematic project is given to a successful person, he takes up the task and finds ways to overcome the difficulties. In contrast, the unsuccessful person's response to a similar project is a series of excuses and discussions about the barriers which will stop him from a successful execution with the conclusion that he should not take up the task.

Of course the CAN DO attitude is the attitude of a confident person, and confidence is the result of many successful accomplishments. There seems to be a paradox here: one needs confidence to be successful, but one has to be successful first to gain confidence. For this reason, one needs to start with smaller tasks that have a higher chance of success to build up confidence. Then one can then take on more complicated projects. There are bad managers who hand over difficult tasks to inexperienced employees who are not prepared for the job. This may destroy the employees' confidence and kill their successful careers.

The person who takes responsibility writes his own fortune, he completes his work with sincerity which gives him both satisfaction and happiness.

We all make a lot of mistakes in our life but the person who understands his responsibilities or takes responsibility never imposes his mistakes on others, does not blame someone else, but accepts his mistakes. With all the negative people in this world and those who get rid of their responsibilities, whenever something bad happens to them, they blame others.

Most people take credit immediately if something good happens, but very few people are the ones who accept their responsibility in case of mistake by themselves. A person who understands his responsibility never blames others. You must have seen many people when they start blaming all of them-their parents, friends, God, relatives, planetary constellations, gurus, destiny, if anything goes wrong with themselves. Such people are very dangerous because these people are about to seek shortcuts in every work.

If they want to be successful, they will look for a shortcut, they will be seen to have big dreams in their mind, but when they are asked to do something then they will not take any step for this or understand their responsibility. The person accepting responsibility does not just dream, lives those dreams, and unites them day & night to fulfill them. But those who do not understand their responsibility are just complaining and are seen crying in some corner or are seen passing time in the street.

We can become a good citizen of this country only when we are ready to bear our own burden. When we are assigned a task and we ask someone to do something to another that second to a third and then third to a fourth, made that work will just go round and round, it will never be completed. People will not be successful, who is seen putting their responsibility on the shoulders of others. If you wish to be great, then understand the value of your responsibility.

Be prepared to bear your own burden rather than blaming others. A good person never becomes good by his deeds or inefficiency, but by understanding his responsibility.
